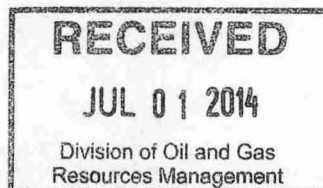

American Energy – Utica, LLC respectfully submits the revised plats and a check in the amount of \$150.00 (\$50.00/revised plat) for the Red Hill Farms MDS GR 1H, 3H, and 5H, located in Madison Township, Guernsey County, Ohio.

The Red Hill Farms MDS GR unit size will remain the same. Parcel nos. 10 & 12 were off by 0.001 acre, causing the acreage of the unit to be 638.923 instead of 638.922. The enclosed plats now reflect the correct unit acreage of 638.922.

The payment of \$50 for a unit change will be deducted from the additional \$250 that was erroneously placed on the Bedway UNN BL 1, 3, and 5 strat permit application, check no. 000005956, sent to ODNR on June 23, 2014. Attached is the breakdown of what has previously been deducted from the check.
